



## Student Code of Conduct

Brunel University London is a great place to live, study, work and socialise and it's up to all of us to make sure it stays that way. We are proud of our inclusive, diverse, and supportive community, and work in partnership together to encourage and promote an equitable, happy, safe and secure environment for staff, students and visitors. In fostering a culture of respect, courtesy, tolerance, and kindness, we demonstrate our commitment to ensuring high standards of behaviour in our work, study, research and social activity, both on and off campus, and whether online or in person.

As members of our community, please act responsibly and considerately and encourage others to do so as well. If any of our students behave in a way that adversely affects the wellbeing and safety of others, either on campus or in the wider community, we will take action to protect everyone else.

We expect good conduct from all our students and have clear expectations around this. All students when enrolling at Brunel agree to adhere to the University rules and regulations on academic and non-academic misconduct, and fitness to practise: [Senate Regulation 6: Student Conduct \(Academic and Non-Academic\)](#) and [Senate Regulation 14: Fitness to Practise](#).

## Good Conduct

Good conduct involves being aware of your own behaviour and attitudes and the impact that your actions, or the things you say, or write, could have on other people. It means taking responsibility for your behaviour, acting with consideration and courtesy towards others, and understanding that there may be negative consequences if your behaviour is unacceptable and upsets others. As a Brunel student, good conduct is expected anywhere and at any time, including in your online activity, such as using social media and online gaming, as well as in the local community and on campus, such as in halls of residence, in your formal teaching space and in the library. Good conduct also applies during placement, and whilst engaged in any other Brunel-related activity, such as a club or society event.

### Unacceptable Conduct

<ul style="list-style-type: none"> <li>• Not complying with the Student Code of Conduct;</li> <li>• Breaking the law</li> <li>• Threatening or engaging in violence, harassment, hate crime, micro-aggressions, bullying or abuse, either physically, verbally, or online, such in the use of social media, including identifiable private accounts;</li> <li>• Sexual misconduct, such as sexual harassment, sexual assault, sexual abuse and any conduct of a sexual nature that is unwanted, including conduct online and on social media;</li> </ul>	<ul style="list-style-type: none"> <li>• Plagiarism;</li> <li>• Unpermitted recycling / re-using work;</li> <li>• Cheating;</li> <li>• Collusion;</li> <li>• Contract Cheating;</li> <li>• Research Misconduct;</li> <li>• Submitting fraudulent extenuating circumstances claims or falsifying evidence in support of extenuating circumstances claims or academic appeals;</li> </ul>

<ul style="list-style-type: none"> <li>• The possession, use or supply of drugs (including the misuse of prescription drugs or legal highs);</li> <li>• The possession or use of weapons;</li> <li>• Anti-social behaviour, including anti-social behaviour arising from intoxication from alcohol or drugs;</li> <li>• Damaging or stealing property and theft;</li> <li>• Unauthorised entry onto or unauthorised use of premises;</li> <li>• Inappropriate use of IT equipment, the University network, the Internet or social media, including inappropriate messaging or posting on both personal, or University-related chat or message groups, visiting inappropriate websites, uploading/downloading inappropriate content and the transmission of computer viruses;</li> <li>• Failing to disclose relevant criminal convictions in line with the <a href="#">Admissions Policy</a>;</li> <li>• Preventing or interfering with lawful freedom of speech or belief, or failing to uphold the principles of the University's <a href="#">Freedom of Speech Statement</a>;</li> </ul>	<ul style="list-style-type: none"> <li>• Breaches of any University rules, regulations, policies or procedures relating to academic activity or assessment;</li> <li>• Failing, without good reason, to cooperate in the University's process of assessment;</li> <li>• Providing work to websites/repositories where the purpose is for the work to be shared, and/or selling work for any sort of gain (financial, work in kind, credit or similar) in order to facilitate an unfair academic advantage.</li> </ul>
